

## **Mission Focus:**

## **History:**

1972: Methodist denomination adopts language about gay marriage and ordination of gay clergy into the Book of Discipline. Every general conference since has seen debate by progressives, centrists and traditionalists.

**2019:** Factions agree to an "amicable" division to be ratified at general conference in 2020.

**2020:** Covid happens. General conferences cancelled until 2024. Support for the "amicable" agreement breaks down. The pathway for churches to leave the UMC with their property and minimal financial cost is set to sunset on December 31, 2023

**2022, Spring:** Traditionalists start a new denomination, the Global Methodist Church pledging to keep the language of marriage and ordination as it has been from the start.

**2022, Fall:** FUMC determines the 1/31/2023 deadline could potentially work against the wishes of our congregation. DS supports a discernment process (labeled a "disaffiliation" process) to uncover the true desires of our congregation over this issue, our future, and our denomination preference.

**2023:** FUMC Ad Council toils on background information for our congregation to discuss the situation, ask questions, understand options and reach some conclusion.

**Next step:** Ad Council announces discernment process for congregation with church meetings set for 2/12/23, 2/19/23, 2/26/23 and possibly beyond.

#### A Question of Affiliation Part two

Methodist churches, including ours, are faced with a decision about future denominational affiliation. Should we be United Methodist? Should we be Global Methodist? Should we be independent or other?

See the sidebar for a brief history describing how we arrived at this point and why now. A second side bar "Ford vs Fred" is an analogy that attempts to simplify the situation to create better understanding.

First UMC has launched the process to engage in discernment over this issue. This should ideally involve our entire congregation. Following two informational meetings and one or more sessions of structured discussion our congregation may determine that it is proper to disaffiliate from the United Methodist denomination. If so, that would require a two thirds (2/3) vote of church members present and voting at an official church conference. If we arrive at such a vote it will not likely happen before March of this year. All members will be notified and absent members will be allowed to participate via Zoom.

If the discernment process leads to a strong leaning to remain in the United Methodist denomination no vote will be necessary.

#### Schedule

1/27/2023: Letter to the entire congregation announcing the discernment process

2/12/2023: Sunday 10:15 AM Meeting #1. Information and Q and A with Global Methodist (Traditionalist) representative Rev. Wesley Gabel

2/19/2023: Sunday 10:15 AM Meeting #2. Information and Q and A with United Methodist representative.

2/26/2023: Sunday 10:15 AM Meeting #3. Full congregation meeting for structured discussion to hear from everyone and discern our best path forward.

March 2023: More discernment meetings if needed. Follow up communication from leadership if needed to gain everyone's input. Possibly unofficial straw poll to guide next steps. If indicated, a call for church conference to proceed with official vote on disaffiliation.

All meetings will have Zoom access. Email (office@lindstrommethodist.org) the church office one week before each meeting to get details on accessing the link.

Hopefully it is clear that First UMC leadership is making every effort to include everyone in this very important decision. Please seriously consider your role as a participant in this church. Our best decision requires full engagement.

#### **Council recommendation**

#### **New Business:**

Worship Coordinate/Worship Planning position – currently filled through February with Terry Keesee and Cindy Kopp. Looking for someone starting March 1. Pastor Chris will be working a rotation for the time being. The current budget is \$25/Sunday for worship coordinator. Anyone interested can contact the SPRC for more information.

Trustee Committee – the committee needs to vote for their own chair. Lloyd Jones has been voted in for 2023 for a one-year term.

Discernment Process Update: Terry contacted the conference for assistance. The goal is to get as much information as possible regarding the discussion surrounding the United Methodist Church and Global Methodist Church. Cindy Gregorson is available to meet with the Ad Council Tuesday, January 24th at 7 PM. We may be able to use Zoom for folks who may not be able to make it. Terry will confirm tomorrow.

- Terry asked the Ad Council to prepare questions for Cindy's visit. Terry will compile and send the list.
- Brief discussion on membership status. A definition is needed to define active, associate, and affiliate member status.
- Terry reviewed the 32 item discernment questionnaire answers submitted by various committees.
- The Ad Council will continue the discernment process and plan for Cindy's visit next week.
- Terry will put together articles for the monthly newsletter and bulletin with supporting information.

The goal of the discernment process is to create a consensus to move the church in a common direction.

#### **Committee report:**

### **Administrative Council 1/2023**

The purpose of the Administrative council is to provide for planning and implementing a program of nurture, outreach, witness, and resources in the local church. It shall also provide for the administration of its organization and temporal life. It shall envision, plan, implement, and annually evaluate the mission and ministry of the church. The church council shall be amenable to and function as the administrative agency of the charge conference

The council acts on behalf of the congregation's decisions made annually at the charge conference. Throughout the year the council carries the authority to oversee the workings of the church within the structure approved at the charge conference.

Our Ad Council meets monthly on the third Tuesday. Meeting requirement is minimally once per quarter. The council is made up of 13 members currently. 8 committee chairs, lay leader, recording secretary, at large position, chair person, and the pastor.

Nearly all church administrative business comes before the council for approval. There are a few exceptions, particularly regarding staff employment and some trustee matters. Most of the business actions regarding attention to all the church ministries are delegated to appropriate church committees with oversight approval by the council. Specific ministries cited in the book of discipline include education, worship, Christian formation, membership care, small groups, and stewardship. Also outreach ministries including church and society, global ministries, higher education and campus ministry, health and welfare, Christian unity and interreligious concerns, religion and race, and the status and role of women. Finally witness ministries such as evangelism, sharing stories of Christian experience, communications, Lay Servant Ministries and other means that give expressions of witness for Jesus Christ.

## **Committee Report Administrative Council Continued**

Required duties of the council also include a) reviewing membership; b) filling interim vacancies between sessions of the annual charge conference; c) establishing the budget; d) recommending to the charge conference the salary and other remuneration of the pastor and staff; e) reviewing and reporting for approval to the charge conference the housing provisions for the pastor.

This past year we have accomplished the creation of an organizational committee structure to efficiently carry out the administrative functions of the council, with hope to free the council to put greater effort into evaluation of our ministries and visioning for the future. A great challenge for this coming year is our immersion in the administration of serious denominational concerns, which threaten to strain our creative abilities.

My personal thanks to all the administrative council members who have committed to meeting these duties as well as possible.

#### Ford vs Fred

#### Initially presented in Sunday morning service 1/22/2023

Henry T Carman drives a Ford F150 pickup truck. He also owns a Ford Bronco and a Ford Escape. In his garage he has a classic 1969 Ford Mustang. Henry is a Ford man and comes from a long line of Ford men and women. His Great Grandfather is said to have met Henry Ford himself.

Henry loves cars and trucks. He has driven other makes, Chevys, GMCs, but has found them wanting. He is a Ford man. 25 years ago Henry and eleven other partners acquired equal shares of a local auto dealership and they have been selling Fords exclusively ever since.


In recent years the Ford line has put out a few hybrid vehicles and an all electric car. Henry's dealership has sold only a few. Six months ago the Ford corporation announced they would no longer manufacture any internal combustion engine vehicles, not even hybrids. "We are going all electric," read the press release. Two months later a group of minority shareholders started a new vehicle manufacturing company which they named Fred Motors. They pledge to make all the classic Ford models, Mustang, F series pickups, Broncos, maybe even an Astrovan and Taurus. They will all have internal combustion engines.

At that point Henry Carman and his 11 partners got together and began considering options. It turns out that they rent their dealership property from Ford and the manufacturer has said they have a grace period of this year only to purchase the property for a reasonable fee if they intend to change over to become a Fred Motors dealer. If they continue to sell exclusively Ford models then the arrangement does not need to change.

The twelve partners soon discovered that they were of varying opinion. Henry himself realized he was not primarily a Ford man, he was really an internal combustion man so he favored using the buyout and switching to Fred Motors. Mary, head of sales argued for staying with Ford, "because we will sell more vehicles with them." Jimmy the service manager said he could go either way, he just wants as little disruption as possible. He then adds, "Why can't we sell both Fords and Freds?"

All twelve were distressed as they realized this was an important decision that carried some urgency. They also understood that this could disrupt their partnership even though this was not of their own doing. Dylan, the parts manager sighed. "Oh, the times they are a changin"
